ORDER

(Partial Extension of Stay of Proceedings)

Before the Honourable Mr. Justice R.W. Elson in Chambers the 18th day of June, 2021.

Upon application by Jeffrey M. Lee, Q.C. and Paul Olfert, counsel on behalf , Alvarez & Marsal Canada Inc. ("**A&M**"), Court-appointed Monitor of Contour Realty Inc. ("**Contour**") and Court-appointed Receiver of 101098672 Saskatchewan Ltd., Morris Industries Ltd., Morris Sales & Service Ltd., and Morris Industries (USA) Inc. (the "**Receivership Entities**"), and upon hearing from counsel on behalf of other parties participating, and upon reading the Notice of Application dated June 15, 2021, the Seventeenth Report of the Monitor dated June 15, 2021 (the "**Seventeenth Report**"), the Confidential Appendices to the Seventeenth Report of the Monitor (the "**Confidential Seventeenth Report**") and a form of Draft Order, all filed with proof of service; and upon reading the pleadings and proceedings herein;

THE COURT ORDERS:

1. The term of the Amended and Restated Initial Order granted by the Honourable Mr. Justice R.S. Smith in these proceedings on January 16, 2020 (the "**ARI Order**"), and the stay of proceedings provided for therein, insofar as they pertain to Contour, shall be and are hereby extended from 11:59 p.m. on Friday, July 30, 2021 to 11:59 p.m. on Thursday, September 30, 2021.
2. All activities, actions and proposed courses of action of A&M from March 23, 2021 to and including June 18, 2021 (collectively, the "**Actions of A&M**"), in relation to the discharge of its duties and mandate as Monitor of Contour, and Receivership of the Receivership Entities, pursuant to the various Orders of the Court of Queen's Bench for Saskatchewan in these proceedings (collectively, the "**Actions of A&M**"), as such Actions of A&M are more particularly described in the Seventeenth Report and the Confidential Seventeenth Report, shall be and are hereby approved and confirmed.
3. All of the professional fees and disbursements of A&M and its legal counsel, MLT Aikins LLP, from March 27, 2021 to and including May 31, 2021, as more particularly described in the Seventeenth Report, shall be and are hereby approved and confirmed.

4. The Confidential Seventeenth Report shall be kept sealed and confidential and shall not form part of the public record, but rather shall be placed, kept separate and apart from all the other contents of the Court file, in a sealed envelope which shall bear a notice which sets out the title of these proceedings and a statement that the contents are subject to a sealing order and shall only be opened upon further Order of the Court.
