NOTICE OF MOTION

The Non-Party, McKesson Canada Corporation, will make a Cross-Motion to a hydge presiding over the Commercial List on Friday August 9, 2019 at 10:00 a.m. or as soon after that time as the Motion can be heard at the Courthouse, 330 University Avenue, Toronto, Ontario.

PROPOSED METHOD OF HEARING: The Motion is to be heard orally.

THE MOTION IS FOR:

1. An Order compelling the receiver, Alvarez & Marsal Canada Inc. (the "Receiver"), or in the alternative Aird & Berlis LLP holding funds in trust for the Receiver, to pay, from the funds held in trust to the benefit of the Defendant Lilian Fam, to McKesson Canada Corporation the sum of \$70,476.27 plus \$1,130.00 in costs and \$1,761.71 in post-judgment interest in satisfaction of the judgment issued April

17, 2018 bearing the Toronto Superior Court of Justice file number CV-17-586970 (the "Judgment");

2. In the alternative, an Order granting McKesson Canada Corporation leave to issue a Notice of Garnishment against the assets of its judgment creditor, Lilian Fam, which are being held in trust by the law firm, Aird & Berlis LLP, for the sum of \$70,476.27 plus \$1,130.00 in costs and \$1,761.71 in post-judgment interest in satisfaction of the Judgment which it holds in trust for the Receiver;
3. Costs of the attendance, if opposed; and
4. such further and other Relief as to this Honourable Court may seem just.

THE GROUNDS FOR THE MOTION ARE (Specify the grounds to be argued, including a reference to any statutory provision or rule to be relied on)

1. On April 17, 2018 McKesson Canada Corporation was granted Judgment bearing the Toronto Superior Court of Justice file number CV-17-586970 against Lilian Fam, for the sum of \$70,476.27 plus \$1,130.00 in costs;
2. To the date of this motion, \$1,761.71 in post-judgment interest has been accrued.
3. After obtaining the Judgment McKesson attempted to execute on the Judgement by registering a Writ of seizure and sale and arranging examination aid of execution.

4. By Order of September 11, 2018 (and amended October 17, 2018) of the Honourable Mr. Justice McEwen, the Receiver was appointed with the powers to take possession of and collect the assets and receivables of the Defendants;
5. The Restated Order of Justice McEwen of October 17, 2018 required *inter alia* that no proceedings against the Defendants may continue and that no creditor may exercise rights or remedies against the Defendants without leave of this Court;
6. McKesson Canada Corporation has not received any payments from Lilian Fam since the date of the Judgment;
7. The Sixth Report of the Receiver indicates at paragraph 8.7 that the Receiver realized on approximately \$513,000 of Domestic Property in Lilian Fam's name that is not traceable to funds received from constructive trust claimants and that those funds are segregated from the proposed distribution;
8. The Sixth Report of the Receiver indicates at paragraph 8.8 that the Receiver received proven unsecured claims of approximately \$77,700 against Lilian Fam of which the vast majority is in favour of McKesson Canada Corporation;
9. McKesson Canada seeks to execute against the funds that are in the hands of the receiver to satisfy its Judgment;
10. McKesson Canada should not be required to wait for the outcome of a lengthy contested trial prior to executing on its outstanding Judgment;

11. Rules 1.04, 2.01, 3.02, 37, 60.02, 60.08, 60.17 and 60.19 of the *Rules of Civil Procedure*; and
12. Such further and other grounds as the lawyers may advise.

AFFIDAVIT OF CHRIS BOOTHROYD

I, Chris Boothroyd of the City of Mississauga, in the Province of Ontario, MAKE OATH AND
SAY:

1. I am a Supervisor of Credit & Financial Services for McKesson Canada Corporation ("McKesson") and as such have knowledge of the matters hereinafter deposed to.
2. On April 17, 2018 McKesson obtained default judgment against Lilian Fam bearing the Toronto Superior Court of Justice file number CV-17-586970 against Lilian Fam, for the sum of \$70,476.27 plus \$1,130.00 in costs (the "Judgment"). Attached hereto and marked as **Exhibit "A"** is a true copy of the Judgment.
3. After obtaining the Judgment McKesson attempted to execute on the Judgement by registering a Writ of Seizure and Sale and arranging Examination in Aid of Execution. Attached hereto and marked as **Exhibit "B"** is a true copy of the Writ of Seizure and Sale filed at Brampton on June 6, 2018 against Lilian Fam. Attached hereto and marked as

Exhibit "C" is a true copy of the Notice of Examination and Certificate of Non-Attendance of Lilian Fam dated July 17, 2018.

4. Those efforts were terminated with the Order obtained Appointing of the Receiver and staying execution, which order was obtained without notice to McKesson Canada.
5. To the date of this Affidavit no monies have been received by McKesson Canada from Lilian Fam in satisfaction of the Judgment.
6. To the date of this Motion, being August 9, 2019, I do verily believe it to be true that \$1,761.71 in post-judgment interest will have accrued on the amounts owed in the Judgment.
7. By Order of September 11, 2018 (and amended/restated October 17, 2018) of Justice McEwen Alvarez & Marasal Canada Inc. (the "Receiver") was appointed as the Receiver over the Defendants.
8. The Sixth Report of the Receiver indicates at paragraph 8.7 that the Receiver realized on approximately \$513,000 of Domestic Property in Lilian Fam's name that is not traceable to funds received from constructive trust claimants and that those funds are segregated from the proposed distribution.
9. I do verily believe it to be true that the \$513,000 of domestic property is being held in trust for Lilian Fam and/or the Receiver by Aird & Berlis LLP (the "Fam Realization Funds").

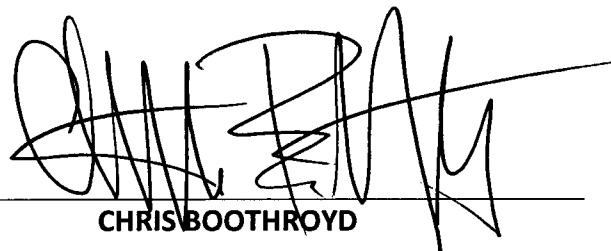
10. The draft Distribution and Discharge Order at Tab 2 of the Motion Record of the Receiver reflects at paragraph 9 an intention to pay into court the Fam Realization Funds.
11. The Sixth Report further indicates at paragraph 8.8 that the Receiver received proven unsecured claims of approximately \$77,700 against Lilian Fam of which the vast majority is in favour of McKesson Canada Corporation.
12. McKesson Canada requests that the Judgment (including costs and post-judgment interest) to be immediately paid out to it before the balance of the Fam Realization Funds (as defined in the Sixth Report) is paid into this Court.
13. In the alternative, McKesson Canada requests that this Court grant it leave to issue a Notice of Garnishment against the funds, currently held in trust for the Receiver and/or Lilian Fam by Aird & Berlis LLP in the amount of the Judgment plus costs and interest.
14. I believe that it would be unfair and prejudicial to McKesson to require McKesson to await the outcome of the proceedings by the Plaintiff against Lilian Fam before it can collect its pre-existing Judgment.
15. I make this Affidavit in support of McKesson Canada Corporation's cross-motion for the immediate payment of its Judgment by Lilian Fam and for no other, or improper, purpose.

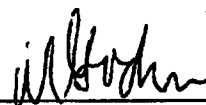

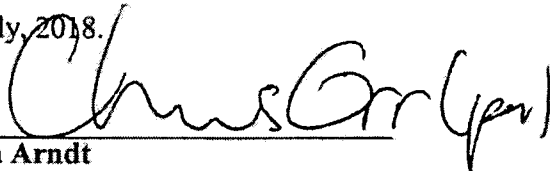

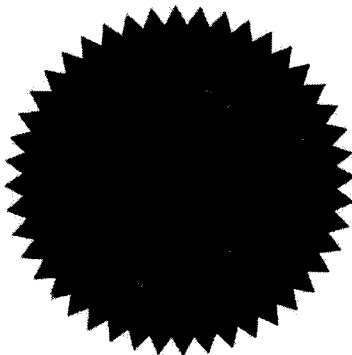
